

"Commercial motor vehicle" means any vehicle which is not owned or operated by a governmental entity, which uses special fuel or motor fuel on the public highways, and which has a gross vehicle weight of 10,001 pounds or more, or has three or more axles regardless of weight, or is used in combination when the weight of such combination exceeds 26,001 pounds gross vehicle weight. (CMV is defined in F.S.S 316, 320, 322, 207; definition may / will vary depending on Chapter)

### CDL LICENSE REQUIREMENTS

<u>Class A</u>: Any combination of vehicles with a Gross Combination Weight Rating (GCWR) of 26,001 lbs. or more, provided the Gross Vehicle Weight Rating (GVWR) of the vehicle(s) being towed is in excess of 10,000 lbs.

<u>Class B</u>: A Single Vehicle with a GVWR of 26,001 lbs, or more, or any such vehicle towing a vehicle not in excess of 10,000 lbs. GVWR.

<u>Class C</u>: Any vehicle, with a GVWR of less than 26,001 lbs, which is designed to transport 16 or more passengers, including the driver, or is used in the transportation of Haz-Mat, which would require the motor vehicle to be placarded.



- Fire extinguisher must be carried and charged F.S.S. 316.215 or 316.302(1)(a) Non-moving (minimum ratings 49 CFR 393.95)
- Load: dropping, shifting, blowing, escaping, not covered F.S.S. 316.520 Non-moving (AG Exemption for covering in certain scenarios)
- 5) Load not secured by chains or stays F.S.S. 316.525 Non-moving

316.215 - It is a violation of this chapter for any person to drive or move, or for the owner to cause or knowingly permit to be driven or moved, on any highway any vehicle, or combination of vehicles, which is in such unsafe condition as to endanger any person, which does not contain those parts or is not at all times equipped with such lamps and other equipment in proper condition and adjustment as required in this chapter, or which is equipped in any manner in violation of this chapter or for any person to do any act forbidden, or failure to perform any act required, under this chapter.
